CIRCULAR

Subject: <u>Waiver of processing fees and penalties charged from KVs/JNVs/State</u> <u>Government Schools affiliated to CBSE in the event of</u> <u>corrections/modifications in LOC after closure of due date- Conditions</u> <u>thereto.</u>

Each year, CBSE issues circular indicating there in the detailed instructions and Standard Operating Procedure for submission of List of Candidates (LOC) for ensuing class X/XIIBoard Examinations. The LOC data with requisite fees is collected through Pariksha Sangam available on the CBSE website <u>https://cbse.gov.in</u>.

Subsequent to finalization of LOC data, the KendriyaVidayalays (KVs), Jawahar Navoday Vidyalays (JNVs) and State Government schools approach CBSE for waiver of late fees/penalties. The waiver of fees/penalties is sought on various grounds viz. inability of students to pay late fees, Government schools do not have funds to pay late fees, by mistake wrong subject was selected mistakenly, clerical mistake etc.

The matter has been reviewed in the Examination Committee of the Board and it is found that without any onus for mistakes, the schools seek waiver of fees/penalties. It is pertinent to mention that disciplinary action should be taken against the erring officials of the school by their respective Competent Authority so that such mistakes do no recur in future. It is, therefore, decided that no request for waiver shall be entertained unless the concerned Competent Authority of the schools provides proof in support of disciplinary action against the officials who have committed mistakes while processing initial LOC data filling.
