ISSUE OF UNIVERSAL DISABILITY ID BY SERVICE HOSPITALS

- Persons with Disabilities (PwD) and their next of Kin (NoK) are eligible for various Central and State/ Union Territory (UT) Government benefits, to include educational opportunities, employment opportunities, workplace assistance, travel concessions etc. as stipulated under Right of Persons with Disability (RPwD) Act, 2016 and the rules and guidelines promulgated therein by various governments. PwD may avail these benefits on the basis of a certificate issued by Competent Medical Authorities (CMAs) notified by the States/ Union Territories (UTs). Foremerly, this certificate was issued on the basis of PwD Act, 1995. Vide Government of India (Gol), Ministry of Defence (MoD) Defence Medical Gazette Notification dated 18 Feb 2009, 36 Army Hospitals could also issue Disability Certificates to serving Armed Forces personnel, veterans and their dependents.
- 2. The notification was issued based on Person with Disbility Act, 1996 (now repealed vide RPWD Act, 2016).
- 3. Ministry of Social Justice & Empowerment vide their notification dt 05 May 2021 (copy att) have specified that Disability Certificate would only be granted on the Unique Disability Card (UDID) portal. O/o DGAFMS took up the case for onboarding AFMS Hosps on UDID portal.
- 3. A DO from Shri Rajesh Aggarwal, Secretary, Ministry of Social Justice and Empowerment, addsd to the Chief Secretaries of 36 States and UTs for assisting the process of authorization of AFMS hospitals for issuing Disability Certificate and UDID Card recd vide O/o DGAFMS/DG-3D note No 16307/18 (c)/Dis Cert/DGAFMS/DG-3D 10 Nov 2023 and the same has been disseminated vide this Dte Gen letter No B/76782/ECHS/Policy/DGMS-5B dt 22 Nov 2023 (copy att).
- 4. Ministry of Social Justice and Empowerment, Dept of Empowerment of Persons with Disability vide OM No P-13013/77/2023-UDID/IT/STATISTICS dt 24 May 2024 has notified 48 AFMS Hospitals for issuance of Disability Certificate and UDIS card and the same has been disseminated vide this Dte Gen letter No B/76782/ECHS Corres/DGMS-5B dt 31 May 2024 (copy att).
