ELIGIBILITY CRITERIA FOR PUBLISHERS WHO WOULD DEPOSIT TEXT BOOKS FOR SELECTION AT HQ AWES

1. Acceptance of terms and condition of EOI.
2. The Bidder should have submitted ₹ 15,000/- towards the cost of the EOI (non refundable).
3. The Bidder should ensure registration with appropriate statutory authorities and should enclose a copy of their registration with Income Tax etc. as applicable.
4. Details of similar completed works during last 3 years. Performance Client Report of such work (Minimum 2 tenders awarded).
5. The Bidder should have submitted the proof of financial capability Minimum average 10 Crores Turnover in last 3 years (copy of financial statement, balance sheet).
6. The Bidder should have well qualified staff for providing the services required (documentary evidence is required).
7. The Bidder should be a company registered in India. The company must be having its operation for more than 05 years in India.
8. School presence : Presence in CBSE/Schools in India.
9. ISBN Registration : Must be available.
10. Distribution Network : PAN India.
11. Should be prepared for mid course alignment to NEP 2020, without disruption/cost implications.
12. Litigation : Affidavit that there is no litigation pending for Royalty/Copyright disputes of the selected book.
